Notice of Intention to issue a Memorial of Amalgamation Pursuant to the *Anglican Church Act, 2003* and Canon SIX

To: The Corporation of the Anglican Parish of Hillsborough Riverside

And To: The Corporation of the Anglican Parish of Moncton

And To: The Corporation of the Anglican Parish of St. Andrews, Sunny Brae

And To: The Corporation of the Anglican Parish of St. James, Moncton

And To: The Corporation of the Anglican Parish of St. Philip's, Moncton

I, David, by Divine permission Bishop of Fredericton, give notice of my intention to issue a Memorial of Amalgamation in the form of the attached Draft Memorial, on or after 1 January 2024.

As required by Canon Six, subsection 11(2), I direct your incumbent, priest-incharge or other assigned cleric, or your church wardens, forthwith to:

- a) Post a copy of this Notice, together with the attachment, in a conspicuous place in each church building in the parish;
- b) Cause this Notice, together with the attachment, to be read at each worship service in the parish for at least four weeks;
- c) If your parish publishes bulletins, cause this Notice, together with the attachment, to be published in the bulletins for at least four weeks; and
- d) If possible, post this Notice, together with the attachment, on your parish web site and circulate the Notice electronically to voting members in the parish.

Take further notice that Canon Six, subsection 11(3), provides that the Parish Corporation or any ten persons who worship in a church or churches in the parish and who are eligible to vote at meetings of the parish community may, within three months after the date of this Notice, notify me in writing that they object to the proposal, setting out their grounds of objection.

Memorial of Amalgamation of the Corporations of the Anglican Parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton

WHEREAS the Anglican Church Act, 2003, provides for amalgamation of parishes of the Anglican Church of Canada within the Diocese of Fredericton, and

WHEREAS the Parish of Hillsborough Riverside was established by memorial on 1 January 1979 on division of the former Anglican Parish of Riverview and Hillsborough, and

WHEREAS the Parish of Moncton was established in the mid-19th century under the name of Rector, Church Wardens and Vestry of St George's Church in the Parish of Moncton with boundaries coincident with the civil parish of Moncton and from which the Anglican parishes of St Andrews, St James and St Philip's were later divided off, and

WHEREAS the Parish of St Andrews, Sunny Brae was established by memorial on 1 September 1999 on division of the Parish of Moncton, and

WHEREAS the Parishes of St James, Moncton and St Philip's, Moncton were established by memorial on 1 May 1960 on division of the former Parish of Moncton West and North West, which parish was established by memorial on 14 March 1956 on division of the Parish of Moncton, and

WHEREAS pursuant to Canon Six of the Diocesan Synod of Fredericton, I gave three months' written notice to the church corporations of the Parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton of my intention to issue a Memorial of Amalgamation joining them into one parish, and

WHEREAS none of the church corporations of the affected parishes and no sufficient number of voting members in any affected parish have objected in writing to the proposed amalgamation:

Now, therefore, pursuant to subsection 7(7) of the Anglican Church Act, 2003, I, David, by Divine permission Bishop of Fredericton, do by this Memorial issued under my hand and seal declare that \sim

- (1) The Anglican parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton are amalgamated hereby as one parish under the name of the Anglican Parish of [NAME still to be determined];
- (2) The name of the church corporation of the Parish of [NAME] is The Corporation of the Anglican Parish of [NAME] and, in French, La société paroissiale anglicane de [NAME];
- (3) The community of the Parish of [NAME] is comprised in Westmorland County of the civil Parish of Moncton and in Albert County of the civil parishes of Hopewell, Harvey and Alma and so much of the civil parish of Hillsborough as lies south of the Stoney Creek Bridge;
- (4) All assets and records (including lands, cemeteries, houses of worship, rectories and other buildings, furnishings, altar plate, vessels and ornaments, other chattels, books of minutes, financial accounts, investments) vested heretofore in the Anglican parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton shall vest in the Corporation of the Anglican Parish of [NAME], subject to the same trusts (if any), or as close as legally possible to the same trusts, as heretofore;
- (5) All debts and other liabilities of the Anglican parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton shall be debts and liabilities of the Corporation of the Anglican Parish of [NAME];
- (6) The Corporation of the Anglican Parish of [NAME] is empowered to enter into contracts or other written arrangements with representative voting members of the former Anglican parishes of Hillsborough Riverside, Moncton, St Andrews Sunny Brae, St James Moncton and St Philip's Moncton for management of such of the assets (including lands, cemeteries, houses of worship, rectories and other buildings, furnishings, altar plate, vessels and ornaments, other chattels, books of minutes, financial accounts, investments) associated with the former parishes as they may agree; and
